- 4. The services to be performed, the estimated time to be spent, and the reports to be submitted will be in accordance with the attached Terms of Reference.
- This Contract, its meaning and interpretation and the relations between the parties shall be governed by the Laws of Union of India.
- 6. This Contract will become effective upon confirmation of this letter on behalf of M/s Luminous Infoways Pvt. Ltd. and will terminate on 4<sup>th</sup> January, 2011, or such other date as mutually agreed between the Chief Engineer, World Bank Projects, Orissa and M/s Luminous Infoways Pvt. Ltd.

Ltd. or its staff. M/s Luminous Infoways Pvt. Ltd. shall provide the Chief Engineer, World Bank Projects, Orissa with certification thereof upon request.
- 9. M/s Luminous Infoways Pvt. Ltd. shall indemnify and hold harmless the Chief Engineer, World Bank Projects, Orissa against any and all claims, demands, and/or judgements of any nature brought against the Chief Engineer, World Bank Projects, Orissa arising out of the services by the Agency and it's staff under this Contract. The obligation under this paragraph shall survive the termination of this Contract.
- 10. The Agency agrees that, during the term of this Contract and after its termination, the Agency and any entity affiliated with the Agency, shall be disqualified from providing goods, works or services (other than the Services and any continuation thereof) for any project resulting from or closely related to the Services.
- 11. All final plans, drawings, specifications, designs, reports and other documents or software submitted by M/s Luminous Infoways Pvt. Ltd. in the performance of the Services shall become and remain the property of the Client. The Agency may retain a copy of such documents but shall not use them for purposes unrelated to this Contract without the prior written approval of the Client.
- 12. The Agency undertakes to carry out the assignment in accordance with the highest standard of professional and ethical competence and integrity, having due regard to the nature and purpose of the assignment, and to ensure that the staff assigned to perform the services under this Contract, will conduct themselves in a manner consistent herewith.
- The Agency will not assign this Contract or sub-contract or any portion of it without the Client's prior written consent.
- 14. The Agency shall pay the taxes, duties fee, levies and other impositions levied under the Applicable law and the Client shall perform such duties, in regard to the deduction of such tax, as may be lawfully imposed.

#### TERMS OF REFERENCE FOR ON-SITE MAINTENANCE AND MANAGEMENT OF RTI-CENTRIC WEB-SITE OF ORISSA STATE ROADS PROJECT

The State Government of Orissa (GOO) has, with the financial assistance of the International Bank for Reconstruction and Development (aka the World Bank), initiated the Orissa State Roads Project (OSRP). The Orissa Works Department (OWD) is the executing agency for the OSRP and the OWD has established a Project Management Unit (PMU) to 'drive' the implementation of the Project. The OSRP funding provides inter alia for engagement of consultancy services and technical assistance as required for achievement of comprehensive OWD-centered initiatives on roads sector Institutional Strengthening (IS) and Governance & Accountability (G&A).

The PMU is playing an important upfront role in the overall IS and G&A strategies as well as its responsibilities for overall OSRP implementation. Action is being taken to continue to strengthen the capacity of the PMU, both to meet the complex challenges of the OSRP implementation and to enable the PMU to take the lead within OWD in embracing the GOO policies on *e-governance* and the *Right To Information* (RTI) legislation. In those fields, the PMU needs to have modern IT-based systems and processes for (e.g.) efficient records management and effective web-enabled public information / communication facilities, which will also demonstrate the transparency, accessibility and accountability aims of the Project and of the OWD.

This shall involve full-time on-site assistance of a *suitable interfacing* **technical person** in the fields of ICT-MIS tools and their application, web-based 'information services' systems development and operation, and IT-user training. It has been decided that such assignment alongwith an interfacing expertise shall be secured from *M/s Luminous Infoways Pvt Ltd.*, who are the CSP to the STATE and National PORTAL and has been assigned to maintain the Central Monitoring Mechanism for RTI by the I. & P.R. Department, Government of Orissa, on the basis of fixed-term of approximately 12 months' (i.e. approximately 300 man-days) duration.

In carrying out the assignment of updating the Central Monitoring Mechanism for OSRP by the Agency, the Scope of Services of the interfacing technical person will be focused for On-site Maintenance and Management of RTI-centric web-site for Orissa State Roads Project on the following terms:





- A. Perform the role of Manager, IT Support Services for the PMU of the OWD, having responsibility for comprehensive technical support for the operation and development of the IT assets and computerized operations of the PMU, under the overall direction of the Chief Engineer - World Bank Project and reporting 'in-line' to a designated Executive Engineer in the PMU.
- B. Assess the design and operations of the OSRP website in relation to its planned features and capabilities (including via its intended interactions with other GOO and OWD websites and/or systems), and assist the PMU to develop the OSRP website further as required to achieve efficient, reliable and publicly accessible website capabilities and capacity for OSRP communications, RTI-related public information access, communication of the OWD 'vigilance' framework and easily-accessed 'gateways' for the complaints-handling process in the OWD.
- C. Advise the PMU in the implementation and/or ongoing enhancement of OSRP-centered project management tools and Unit-level management information systems (MIS), to enhance the monitoring and management of Project activities within plans, performance targets and/or budget milestones.
- D. Facilitate and/or directly provide a range of 'IT user training' and 'IT skills improvement' services to PMU staff, to strengthen Unit skills and knowledge in IT / ICT systems usage, in the application of MIS tools and outputs, and in the management and ongoing development of the OSRP website.
- E. Help the PMU to resolve any compatibility and interaction issues between Unit systems / tools and other systems in the wider GOO / OWD environment.
- F. Provide advice (where requested) to PMU management and (if appropriate) to the OWD on PMU-related aspects of any OWD-wide systems development and implementation actions.

#### Reporting

The Agency will prepare monthly report in every month focusing on the scope and outcome from the assignments in the month. The report should cover the plan, target and achievement under this assignment.
