FOUR-LANING WITH PAVED SHOULDERS OF SAMBALPUR - ROURKELA (SH-10)
IN THE STATE OF ODISHA ON DBFOT BASIS

The Chief Engineer (World Bank Projects), Odisha on behalf of the Works Department, Govt. of Odisha (GoO) is engaged in the development of state roads and highways in Odisha and, as part of this endeavour, GoO has decided to undertake development of **Four Laning with Paved Shoulders of Sambalpur – Rourkela Section of SH-10 (from Km 4.900 to 167.900 Km) in the State of Odisha** (the "Project") under public private participation (PPP) on Design, Build, Finance, Operate and Transfer (the "DBFOT") basis, and has decided to carry out the bid process for selection of the parties / consortia to whom the Project may be awarded.

This bid process shall be carried out in the following two stages: (a) The Request For Qualification (RFQ) Stage, wherein interested Applicants shall be short-listed; and (b) The Request For Proposal (RFP) Stage, wherein proposals shall be invited from the short-listed Applicants (the "Bidders"). Brief particulars of the Project are as follows:

The scope of work will broadly include rehabilitation, upgradation and widening of the existing two-lane with paved shoulder carriageway to four-lane with paved shoulders standards with construction of new pavement, rehabilitation of existing pavement, construction and/or rehabilitation of major and minor bridges, culverts, road intersections, interchanges, drains, etc. and the operation and maintenance thereof

Interested parties may obtain the Request for Qualification documents (the "RFQ" document) from the address given below from **08.10.2012 to 12.11.2012** on all working days between 10:00 hrs and 17:00 hrs IST by written request on payment of a non-refundable fee of **INR. 1,36,500/- [Rs.1,30,000/- + VAT 5%]** (Indian Rupees One lakh thirty six thousand five hundred only) by way of cross Demand Draft / Pay Order drawn in favour of "Executive Engineer, Project Management Unit, Odisha State Roads Project" issued by any scheduled Bank payable at Bhubaneswar, India. RFQ documents can also be download from <http://osrp.gov.in> or <http://tenders.gov.in> between **08.10.2012 to 12.11.2012**. In case of downloaded documents, the applicant must submit the aforesaid cost in the prescribed format alongwith the completed RFQ failing which the application shall be rejected.

A Pre-Application conference of the interested parties shall be held at the following address on **26.10.2012 at 16.30 hours IST**. The RFQ document contains information about the Project pre-qualification requirements and the process to be followed.

The undersigned reserves the right to accept/ reject any or all proposals without assigning any reason thereof. The undersigned may update, amend or supplement the information including the qualification process by amendment in the RFQ document at its discretion, under intimation to the Applicants, but before the due date. The proposal of the Applicant would be evaluated in terms of prescribed minimum threshold technical and financial capability criteria applicable to the Applicant (sole applicant/ Consortium as the case may be). Detailed information on the evaluation criteria etc. is available in the RFQ document.

RFQ duly completed in the prescribed manner must be submitted not later than **1600 hrs on 14.11.2012** in the manner specified in the RFQ document at the address given below. The Applications received after the deadline shall be summarily rejected
