1. The Government of Odisha through the Government of India has received loan from the International Bank for Reconstruction and Development (IBRD) in various currencies towards the cost of Odisha State Roads Project. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for following Civil Works Packages.

2. The Chief Engineer, World Bank Projects, Odisha on behalf of the Government of Odisha now invites sealed bids from eligible bidders for the construction and completion of following Civil Works defined in the table below. ("the Works").

3. Bidding will be conducted through the International competitive bidding procedures specified in the World Bank's Guidelines: *Procurement under IBRD Loans and IDA credits. (May 2004)* and is open to bidders from all countries as defined in the guidelines.

4. Interested eligible bidders may obtain further information from and inspect the bidding documents at the address mentioned below.

5. A complete set of bidding document in English language may be purchased by the interested bidders at the address below on payment of a non-refundable fee as indicated, in the form of cash or Demand Draft on any Scheduled Bank payable at *Bhubaneswar, India* in favour of *Executive Engineer, Project Management Unit, OSRP* from **March 16, 2013 to May 16, 2013**. A pre-bid meeting shall be held on **April 8, 2013** in the office of the undersigned at **12:15 Hours**.

In case of downloaded document, the undersigned will not be held responsible if any portion of the bid document is modified / omitted and in such cases the original document kept with in the office of the undersigned shall prevail. Bid documents downloaded from the website, must be accompanied by a non-refundable fee as mentioned in table below towards the Cost of Bid Document in shape of a demand draft from any scheduled Bank of India in favour of the *Executive Engineer, Project Management Unit, OSRP* payable at *Bhubaneswar, India*, failing which the Bid shall be summarily rejected.

6. The provisions in the Instructions to Bidders and in the General Conditions of Contract are the provisions of the World Bank *Standard Bidding Documents: Procurement of Works*.
