**Sir,**

Your reply vide your Letter No. 472 dt. 22.10.2011 to the show cause notice issued by this office vide letter No. 44353 dt. 22.09.2011 is not satisfactory. After detail enquiry it has been established that you have adopted corrupt and fraudulent practice in competing the tender and in executing the contract by deliberately misrepresenting Sri Sangram Kesari Panda as Team Leader to earn higher marks in evaluation during selection process and subsequently engaging Sri Amerendra Pattnaik to impersonate as Sri Sangaram Kesari Panda to function as Team Leader in execution of the contract.

Taking the above facts in to consideration the Government of Odisha in Works Department being the employer of the above contract has been pleased to terminate the contract bearing Agreement No. 12 of 2009-10 under clause 2.6.1 ( C) of the G.C.C of the above agreement with immediate effect.

Accordingly, you are notified to demobilize your men and materials from the P01 road corridor for the above service and hand over the original money receipts, bank drafts for R&R entitlement of PAPs, database of PAPs and all documents, records, files and letters concerning the above consultancy alongwith the inventory to Executive Engineer, Khariar (R&B) Division-cum- Package Manager, P01 within 7 days of issue of this letter under intimation to the undersigned.

Further, in pursuant to Appendix I of the contract you are by required to refund an amount of ₹12,89,448/- (Rupees twelve lakhs eighty nine thousands four hundred forty eight only) towards the upto date consultancy fees received by you against the above contract within fifteen days of issue of this letter.
