- 1. This Request for Expressions of Interest follows the general procurement notice for this project that appeared in *Development Business* issue of *29th September*, *2005*.
- 2. The State Government of Odisha (GOO) through the Government of India has signed a loan agreement (Loan No. 7577-IN) with the International Bank for Reconstruction and Development (World Bank) amounting to US\$250 million equivalent for implementation of Odisha State Roads Project and intends to apply a portion of this loan to finance services for implementation of Social Safeguards in the (Jagatpur-Chandbali and 8 other roads) OSRP.
- 3. The project consists of broadly two components- Road corridor improvement and Institutional Development. The implementation and monitoring of the project is being carried out by the PMU headed by Chief Engineer (World Bank Projects) and assisted by professionals in Engineering, Finance, Land Acquisition, Resettlement and Rehabilitation, Environment etc. Detailed information on the project can be accessed through project website (www.osrp.gov.in).

The Project Authorities want to hire the services of a Social Development Adviser (SDA) for preparation of a Social Safeguard Instrument for the phase-II roads (Jagatpur-Chandbali and 8 other roads) and its implementation. The assignment is to ensure that safeguard measures are properly implemented so that living standards of affected people is restored or improved. The responsibility of the SDA includes assisting in Social Screening, preparation of abbreviated RAP, monitoring surveys and implementation of Social Safeguards in Phase-II roads. Besides, the SDA shall provide overall technical support to PMU in Social management of OSRP.

In this context, the OWD is looking for a Social Development Adviser (Individual Cosutant to prepare and implement a Rehabilitation Action Plan (RAP), Tribal Development Plan(if required), HIV/AIDS awareness and Road Safety awareness plan and undertake con-current evaluations to see whether stated goals were achieved, and suggest corrective measures if necessary.

- 1. The Consultant should be a senior resettlement specialist with 10 years' experience in planning and implementing RAPs and in addressing broader social development issues.

- 3. He/she should have a higher degree in sociology, anthropology, political science, development studies, or other relevant social sciences. Women candidates are encouraged to apply.
